WE DISTRIBUTE FOOD PURCHASED FROM GLEANERS FOOD BANK, TEFAP (THE EMERGENCY FOOD ASSISTANCE PROGRAM) ALONG WITH OTHER COMMODITIES AND DONATED ITEMS FROM COMMUNITY PARTNERS. SUBURBAN HUNGER IS A GROWING CONCERN, AND CARES IS WORKING TO SUPPORT FAMILIES AND INDIVIDUALS THAT ARE EXPERIENCING HARDSHIP.

THESE PRODUCTS INCLUDE FRESH PRODUCE, MEATS, DAIRY, NON-PERISHABLES ITEMS AND PERSONAL CARE PRODUCTS. CARES GUESTS SELECT FOOD AND OTHER ITEMS BASED ON FAMILY SIZE, DIETARY NEEDS, AND AVAILABILITY. EACH GUEST SHOPS FOR THEMSELVES AND HAS A CHOICE TO PICK ITEMS THAT FIT THEIR FAMILY BEST.
